The Council agreed to follow the advice of E Harris regarding the report submitted by R Jenkins. The acknowledgement would be the only letter from the Clerk. Reference to the status of the report had been made in the letter above to Douglas Jones and Mercer.

Agreed to revisit the issue of parking in the November Community Council meeting if no action has taken place by then.

Burry Green Grass Cutting - D Cowley had informed the Clerk he would be cutting this shortly.

Agreed to put a laminated notice in each defibrillator stating where the nearest one was in case the one in the box was already in use elsewhere.
